### PRIVATE HEALTH INSURANCE TERMS AND CONDITIONS FOR USE

- HICAPs available for clients with Private Health Insurance
- It is the client's responsibility to ensure services being provided using Private Health Insurance at BCH are covered under the individual's policy. If not, the full fee will be applicable and payable on the day of the service
- If a client's Private Health Insurance Card has expired or is not valid, the full fee will be applicable and payable on the day of the service
- Once a client has used the maximum number of visits or annual limit under the specific service, the full fee will be applicable and payable on the day of service for any further visits booked for that service
- Excludes Children Services

### ADULT DENTAL: ONLY HEALTHCARE CARD HOLDERS OR PENSIONERS ARE ELIGIBLE FOR ADULT DENTAL SERVICES

**NO FEE applies for the following Dental clients eligible for public dental services:** Aboriginal & Torres Strait Island people, people who are homeless or at risk of homelessness, refugees & asylum seekers

<b>Dental - Emergency Treatment</b>	\$30.50 per course of care
<b>Dental - General Treatment</b>	\$30.50 per visit up to a maximum of \$122 per course of care
<b>Dental - Denture</b>	\$73.00 per denture, capped at \$146 for a full upper and lower denture

### PRE-SCHOOL AND STUDENT DENTAL SERVICES

<b>Service is available to all preschool and primary school students under the age of 13 years.</b>	No fee applies
<b>Service is available to secondary students aged 12 - 18 years who:</b> <ul style="list-style-type: none"> <li>• hold a Healthcare card or are the dependent of a person who holds a Healthcare card or Pensioner concession card</li> <li>• are eligible for the Medicare Child Dental Benefits Scheme</li> <li>• enrolled in a public secondary school</li> </ul>	No fee applies
